At the campsite

Container (waste)

Waste can be deposited in the waste containers of Boerderij het Lansingerland.

Animal pasture

If you want to feed the animals, only give them pieces of bread or apple peels. Do not feed too much at once. NB! Do not give branches or leaves to the animals.

Showers and hot water

You don't need any money for the showers, hot water is free.

The terrace and shop

Come have a drink on the terrace and pick up organic food in the store! Fresh bread can be ordered in the store a day in advance.

Opening hours Monday to Friday: 10:00 AM to 5:00 PM and on Saturday from 9:30 AM to 5:00 PM.

Regulations

Arrival/Departure

Upon arrival, every guest is required to first report to the reception/shop. Check-in is between 12:00 and 17:00. If, due to unforeseen circumstances, you arrive after this time, please let us know during shop opening hours by calling 010-5212912 (available between 10:00 and 17:00).

If you cannot reach anyone, as a last resort, you can contact Peter Gille at 06 - 513 43 526.

On the day of departure, you must leave your accommodation tidy by 11:00 AM. On Sundays, you can stay until 5:00 PM.

Arrivals on Sundays are not permitted.

Camping Rates 2026

The camping rate is €30.00 per night. This price is based on camping equipment, including two people, electricity, and hot water.

A pitch without electricity costs €25.00 per night, including two people.

The municipality of Lansingerland will charge a tourist tax from 2026, and we charge €0.51 per person per night for this.

The minimum number of nights you can book on weekends is two. If you depart on Sunday, you may stay at your pitch until 5:00 PM.

Each additional person is €9.50 per night, regardless of age.

Placement of tent/caravan

Caravans and tents may only be placed at the location agreed at the reception. You must park your car in the designated parking lot. It is not allowed to park your car at your camping spot! Unloading at your spot is of course allowed.

Visitors

Visitors of our guests are welcome. Please report in advance how many visitors there will be per day. Visitors are charged a rate of €3.50 per person per day. The car must be parked in the parking lot of Boerderij het Lansingerland and not at the campsite. If your visitors stay overnight, they must register at reception and the overnight rate of € 9.50 per person applies.

Payment

All reserved places must be paid for upon arrival at the store. In the unlikely event of an earlier departure, we will not provide a refund for an earlier departure amount paid. We advise you to take out cancellation insurance.

Hygiene

Use the toilet and shower as you use your sanitary facilities at home. The sanitary area is not a children's playground. You can dump your chemical

toilet and dirty water in the designated area in the sanitary area.

Liability

The management is not liable for any loss, theft, damage or injury of any kind to the person or property of the camper or visitor.

Traffic

You can park your car in the car park free of charge. Please park any 2nd car in the parking lot of Boerderij het Lansingerland, so that inconvenience at the campsite is prevented. All license plates of cars on the campsite must be known to reception. The parking lots are accessible 24 hours a day.

Pets

Pets are not allowed on our site, not even day visitors. This is in connection with neospora.

Fire hazard

Burning open fires is strictly prohibited. Be extremely careful with fire and never throw away a lit cigarette or match. Barbecuing is allowed. Please observe the following safety rules:

1. Make sure you have a suitable extinguishing agent at hand, at least a bucket of water.
2. Place the barbecue off the ground (to avoid damage to the lawn).
3. Keep sufficient distance from your tent or caravan, awning and trees.

Young people

Young people aged 18 and over are very welcome, but they must adapt to our (family) identity.

Excessive drinking and manifestations thereof will not be tolerated. In case of violation, the management can deny you access to the campsite or order you to leave the site. For group and youth bookings we can charge a deposit of €100. This will be withheld/settled at the end of the period in the event of noise nuisance or destruction or refunded at the end of the period in the event of good behavior.

Smoking ban

Smoking is prohibited in all buildings on our site.

Don't leave cigarette butts that have been kicked out at the campsite!

Rest

Noise should be avoided as much as possible. We are forced to take strict action against disturbers of the peace. Music may not be audible outside your accommodation.

The site must be quiet between 11:00 PM and 8:00 AM.

Maintenance

The user undertakes:

Ensure the cleanliness of the campsite by keeping the pitch neat and clean.

Not to leave any goods at the location at the end of the stay, so that our site remains neat and tidy.

Clean-up costs that we have to incur will be charged.

No holes to dig because of the underground gas, electricity and water pipes.

Sunday rest

Because we want to enjoy a wonderfully quiet Sunday together, arrival on Sunday is not possible.

The reception/shop is also closed on Sundays.

Departure on Sunday is possible.

Order at the campsite

The management reserves the right to order people to leave the campsite immediately if, in its opinion, there is reason to do so. Any instructions given by the police, doctor and staff must be carried out immediately; the latter have the right to enter all places of residence at any time.

Other

No consumables may be delivered by suppliers without permission from management. It is not permitted to distribute leaflets or advertising material in the park, to sell goods, to hold parades or meetings without permission from the management.

It is not permitted to have mail or packages delivered to the campsite. We will not accept these.

General

Management, staff and the persons appointed for this purpose by the government and the municipality are responsible for detecting violations of these regulations. In order to ensure a pleasant stay, please comply with these regulations and behave in such a way that other guests will not be disturbed by you.

We hope that we will have a wonderful time together and will do our utmost to make your stay as pleasant as possible.
